Development of Communities within the Frontenac Lennox and Addington Ontario Health Team January 30, 2025

Technical Notes

Background

Commencing in May 2024, the Ontario Community Health Profiles Partnership (OCHPP) team in collaboration with the Health Services and Policy Research Institute (HSPRI) at Queen's University in Kingston, Ontario, began working together to develop small areas, known as "communities" for the Frontenac Lennox and Addington Ontario Health Team which includes Kingston, Ontario and surrounding areas.

Methods

The communities were created using existing Census 2021 Aggregate Dissemination Areas (ADAs) created by Statistics Canada. An aggregate dissemination area (ADA) is a dissemination geography created for the Census. ADAs cover the entire country and, where possible, have a population between 5,000 and 15,000 based on the previous census population counts. We compiled an original set of 26 ADAs but two were aggregated together to increase the combined populations to reportable levels.

Results

24 Communities* in Frontenac, Lennox and Addington Ontario Health Team (OHT) were developed as part of the collaboration and have an average population of 8,990. Communities was the term chosen for these new small areas by the HSPRI team as it most closely reflects the language used in the area and was more appropriate than other names such as "neighbourhoods."

The final geographies consist of a set of boundaries defining communities, their names and IDs that cover the rural Frontenac, Lennox and Addington sub-region, and respect Census 2021 aggregate dissemination area (ADA) boundaries. See the table below.

The OCHPP team will commence to generate health and socio-demographic data on an on-going basis for these communities. Data and maps will be posted on the publicly-accessible OCHPP website: www.ontariohealthprofiles.ca

*Note: Data will only be reported on 23 communities as one community, Tyendinaga Mohawk Territory will be omitted from data gathering and reporting in order to conform to the Principles of ownership, control, access, and possession (OCAP) (https://fniqc.ca/) which OCHPP honours.
